- B) Kelly Graham Iron Belle Trail Update Continuation of work on terminus for bike path.
- **C)** Road Projects Superintendent Sutton informed board we would be notified of schedule dates for the 3 selected road projects as soon as any time frame is given by the county.
- **D)** Sewer Projects We are still continuing to wait for the environmental study and the rate study. Once that information been determined we hope to have an offer from the USDA to present to the board for consideration.

- **E)** Water Projects Design is slated to begin within the next 2 weeks construction to start the 3<sup>rd</sup> week of April. Completion is targeted for the end of June for McNall and Denise Streets.

#### **NEW BUSINESS:**

- A) Adult Use Marihuana Currently the State of Michigan has filed the extended emergency rules for recreation use, which will be in effect until July 3, 2020. Included in the packet is a draft of an ordinance to be reviewed by the board. This was presented for the purpose of starting a discussion about whether or not to allow recreational marihuana facilities in the township. Treasurer Samotis suggested the board follow the same process they employed to decide on medical marihuana. That involved a board subcommittee that studied the process and laws and ultimately brought a recommendation to the board. No action will be taken at this time.
- B) Mill Street Request We have received numerous requests to add a street light on Mill Street due to safety issues, future bike path, and located near river and guard rail. The cost quoted from Consumer's is \$100.00. Motion by Janis to approve the request for a street light on Mill Street. Second by Graham

## D) Placeholder - Property

Supervisor Beliveau explained that there was a competitive offer for a piece of property that will meet all of the requirements of the Iron Belle Trail terminus. Samotis made the motion to authorize the purchase of Parcel #021-A30-000-116-00 for a price not to exceed \$27,000.00. This will include the purchase price and buyer's share of closing costs. Second by Janis Unanimous – Roll Call Vote

E) Resolution for a Budget Amendment - Provided for the board was a budget amendment to cover the costs of the purchase of land needed to proceed with a terminus for the bike path. This resolution will cover the purchase costs of the parcel until such time that it can be reimbursed, Ramsdell made the motion to approve Resolution 2020-03 To Amend the 2020 General Fund Budget. Second by Barnes
