### **NEW BUSINESS:**

- A) 5G Presentation Mr. Mike Watza of KITCH Attorneys & Counselors gave a presentation to the trustees regarding regulations of cell towers and other wireless facilities which will be coming to our communities in the near future. He also gave a picture preview of cell towers and what they may look like and how their appearance may change as the communication industry expands. Mr. Watza suggested items which may be useful when composing a zoning ordinance to help regulate these small cells. He also explained the possible loss of revenue for the communities if the current legislation is not challenged.
- B) Newsletter Superintendent Sutton provided a copy of the Summer Newsletter to be distributed along with property tax statements July 1<sup>st</sup>.
