# NEW BUSINESS:

#### A) Mr. Jeff Taylor – Permit Request

Mr. Taylor (who was unable to attend this meeting), would like to reestablish the previous Big Boy property as a microbrewery. He added all state and local mandate codes will be observed. Chairman Beck acknowledged the property is located in the R-4 Tourist District, is allowed use (with special approval) under Sec. 4.16 Item H chart in the zoning ordinance of AuSable Township. There were more questions from the board for Mr. Taylor (dimension of lot, setbacks, sign location, location of septic and approve permit, parking spaces, capacity for building, outdoor lighting and type). The permit is tabled until Mr. Taylor provides the information needed.

At this time Chairman Beck acknowledged Mr. Reineck's communication and how the AuSable Township Ordinances and State laws would address some of his concerns.

**B)** Master/Rec Plan Draft Review – Superintendent Sutton provided a draft to review chapters with changes. She asked the board to contact her with any suggestions, questions, or changes before Labor Day. Any edits to the draft will be forwarded to NEMCOG for the completion of the Master Plan.
