OPERATION AND USE OF TOWNSHIP DUMPSTER DAYS

(Replaces Ordinance Number 10, dated March 11, 1965)

Adopted: December 17, 2007

Effective: January 17, 2008

AN ORDINANCE TO REGULATE DUMPSTER DAYS USE

THE CHARTER TOWNSHIP OF AUSABLE ORDAINS:

SECTION 1:

The use of the AuSable Township Dumpster Days shall include AuSable Township property owners and renters. Renters must provide a Michigan Identification card or Michigan Drivers License with an AuSable Township address. All users are required to purchase an annual permit.

SECTION 2:

Dumping shall be restricted to household refuse and wastes only. Manufacturing, construction, wrecking and salvage business wastes are prohibited.

SECTION 3:

The Township Dumpster Days are not intended for garbage disposal and no vegetable or animal wastes or other refuse which shall constitute a health hazard, shall be permitted to be dumped in the Township dumpster.

SECTION 4:

Use of the dumpster shall be under the supervision designated by the Township Board.

SECTION 5:

Any person found guilty of violating the terms of this ordinance shall be deemed guilty of a misdemeanor and subject to a fine not exceeding \$100.00 or imprisonment in the county jail for a period not exceeding 90 days.

SECTION 6:

This ordinance shall be published once, in full, in the Oscoda Press, a newspaper of general circulation within the boundaries of the Township and qualified under State law to publish legal notices promptly after its adoption, and the same shall be recorded in the Ordinance Book of the Township and such recording authenticated by the signature of the Supervisor and the Township Clerk.

SECTION 7:

All ordinances, parts of ordinances, or resolutions in conflict herewith are hereby repealed, however such parts not in conflict shall remain in full force and effect.

SECTION 8: EFFECTIVE DATE

This Ordinance shall be effective thirty (30) days following adoption. At a regular meeting of the AuSable Township Board held on the <u>17th</u> day of <u>December</u> 200<u>7</u>, adoption of the foregoing ordinance was moved by <u>Jan Baldwin</u> and support by <u>Lynn</u> <u>Mitchell</u>.
