# AN ORDINANCE ESTABLISHING CONNECTION CHARGES FOR AUSABLE-OSCODA INDUSTRIAL PARK SANITARY SEWER:

Effective January 21, 1997

#### THE CHARTER TOWNSHIP OF AUSABLE ORDAINS:

### 1. CONNECTION CHARGE

- A. A connection charge for connection to the AuSable-Oscoda Industrial Park sewer system is hereby established at \$975.00 per connection.
- B. The Township Board may from time to time change the connection charge by resolution of the Township Board.
- C. The connection charge shall be paid at the time application is made to connect to the sewer system.
- 2. <u>NO FREE SERVICE</u>: No free service shall be furnished to any person, firm or corporation, public or private, or to any public agency or instrumentality.
- 3. All ordinances and parts of ordinances in conflict with this Ordinance are hereby repealed.
- 4. This Ordinance shall become effective immediately upon adoption.
