

ORDINANCE NUMBER 84

**AN ORDINANCE TO AMEND MUNICIPAL WATER SERVICE RATES**

THE CHARTER TOWNSHIP OF AUSABLE ORDAINS:

SECTION ONE: The municipal water rates for the Charter Township of AuSable, will be as provided in Section Two (2) of this ordinance. All ordinances or portions thereof not inconsistent with this ordinance shall remain in full effect.

SECTION TWO: Section two (2) of Ordinance Number 34 is hereby amended to read as follows:

USER CHARGES: A base charge of \$29.45 per the table below will be charged monthly:

| METER SIZE | EQUIVALENT RATIO | CHARGE    |
|------------|------------------|-----------|
| ¾"         | 1                | \$29.45   |
| 1"         | 2.5              | \$73.63   |
| 1¼ - 1½"   | 5                | \$147.25  |
| 2"         | 8                | \$235.60  |
| 3"         | 15               | \$441.75  |
| 4"         | 30               | \$883.50  |
| 6"         | 50               | \$1472.50 |

In addition, a charge of \$2.94 per 1,000 gallons will be charged from the first gallon of monthly consumption.

UNMETERED USERS: A \$44.18 flat rate per month for all unmetered single-family residential users.

SPECIAL RATES: For miscellaneous or special services for which a special rate shall be established, such rates and who shall pay them, shall be fixed by the Township Board.

BILLING: Bills will be rendered monthly on the first day of each month payable without penalty by 20th day of month. Payments received after such period shall bear a penalty of five (5%) percent of the amount of the bill, and shall in addition thereto, bear an interest rate of twelve (12%) percent per annum of the amount of the bill.

This Ordinance was first read on January 21, 2019, read again on January 28, 2019, and shall become effective upon February 1, 2019.
