

**CHARTER TOWNSHIP OF AUSABLE**

**ORDINANCE NO. 126**

**AN ORDINANCE TO AMEND CHARTER TOWNSHIP OF AUSABLE ORDINANCE 119 (THE TOWNSHIP'S ORDINANCE THAT AUTHORIZES THE LICENSING AND REGULATION OF MARIHUANA ESTABLISHMENTS PURSUANT TO THE PROVISIONS OF THE MICHIGAN REGULATION AND TAXATION OF MARIHUANA ACT), IN ORDER TO REVISE THE TYPE AND NUMBER OF MARIHUANA GROWER PERMITS ALLOWED IN THE CHARTER TOWNSHIP OF AUSABLE.**

THE CHARTER TOWNSHIP OF AUSABLE ORDAINS:

Amendment of Ordinance 119.

Charter Township of AuSable Ordinance 119 is amended as follows:

Section II ("PERMIT REQUIRED; NUMBER OF PERMITS AVAILABLE; ELIGIBILITY; GENERAL PROVISIONS"), Subsection 1-D, of Ordinance 119 lists the types and maximum number of marihuana establishment permits allowed in the Charter Township of AuSable. Ordinance 119 originally allowed one Class A Marihuana Grower permit, zero Class B Marihuana Grower permits, and zero Class C Marihuana Grower permits. Ordinance 119 was subsequently amended by Ordinance 124 to allow zero Class A Marihuana Grower permits, zero Class B Marihuana Grower permits, and one Class C Marihuana Grower permit. The Township is now amending ordinance 119 again in order to change the number of allowable Marihuana Grower permits. Section II, Subsection 1-D, of Ordinance 119 is hereby amended to now read as follows:

**D. Marihuana Grower:**

<b><u>Class A Marihuana Grower:</u></b>	<b>0 permits allowed.</b>
<b><u>Class B Marihuana Grower:</u></b>	<b>0 permits allowed.</b>
<b><u>Class C Marihuana Grower:</u></b>	<b>5 permits allowed.</b>

Effective Date.

This ordinance shall become effective immediately upon its publication as required by law.

Publication; Recordation; Authentication.

This ordinance or a lawful summary shall be published once in a newspaper of general circulation within the boundaries of the Township, and qualified under state law to publish legal notices, within thirty (30) days after its adoption; this ordinance shall be recorded in the record of ordinances book of the Township; and the Township Supervisor and the Township Clerk shall authenticate this ordinance by placing his or her official signature upon this ordinance.

Severability.

The provisions of this ordinance are hereby declared to be severable, and if any clause, sentence, word, section, or provision is hereafter declared void or unenforceable for any reason by any court of competent jurisdiction, it shall not affect the remainder of this ordinance, which shall continue in full force and effect.
