A) Discussion of 2023 Projects – Commissioner London reminded the board of the subject of not allowing storage rentals in residential buildings. Superintendent Strayer has done research of other townships and could not find any allowing storage in that particular situation. He suggested that the board could revisit the home occupation ordinance to see if it would need a Special Land Use Permit. He also offered to contact NEMCOG to find out if they had any experience with this storage situation and how it was handled. The board agreed to revisit this issue.

Another issue that has brought some attention is people buying vacant lots to park their trailers. Discussion began about the township ordinance that might pertain to this, which allows a camping trailer to be parked for 2 weeks on vacant land.

One suggestion was that the property for purchase must be adjacent to the residence or have a permanent residence on it to be acceptable for any trailer storage.

Further research would be done by Superintend Strayer on these subjects.

B) Term Expirations – In May 2023, two terms expire for the Planning Commissioners. Jeff Lamrock has decided to renew his term for another 3-year term, and Superintendent Strayer will contact Mike Pardington to see if he would like to also renew his term. The renewals will go before the board for approval.
