- A) Kelly Graham Iron Belle Trail Update Clerk Graham reminded the trustees of the bids went out for advertisement on April 7<sup>th</sup>, and will be opened 5<sup>th</sup> of May.
- **B)** Sewer Project Superintendent Strayer explained that the lift station were temporarily connected to power because Consumers Energy are installing new transformers. We were notified that due to a material shortage, the installation will be postponed until May.
