**D)** Farmers Market Engineering Proposal – The proposal is for the engineering and architect work necessary for the Trailhead Marketplace is \$37,000. from Fleis and Vandenbrink. \$18,000. Of this will be paid from a DNR grant that must be used by September. The remaining balance will come out of Park & Recreation (Capital Outlay) budget. Another bid was received from Spicer Group in the amount of \$39,500. Janis made the motion to approve the proposal from Fleis & Vandenbrink in the amount of \$37,000. Second by Barnes

**BOARD COMMENTS:** Trustee London had a question on the purpose of the rooms that will be apart of the Pavilion. Superintendent Strayer explained there is space dedicated to restrooms, storage, and possibly bike repair station for the losco Exploration Trail.

**PUBLIC COMMENTS:** Kevin Kubik introduced himself and requested a private meeting with Supervisor Beliveau regarding the vacancy of the Supervisor's position coming up in November. Supervisor Beliveau agreed with the meeting.
